## **Declaration of consent**

for the processing and publication of personal image and sound data as well as (live) streaming recordings

I authorise the Hochschule für Musik Dresden, public and private broadcasting companies as well as television and other production companies to use image and sound data involving lessons, teaching events, rehearsals and performances as well as other events in which I am participating / have participated as part of my studies, on image and sound carriers (incl. video, DVD and similar data carriers).

This image and sound data may be used by the Hochschule für Musik Dresden free of charge and for an unlimited time period.

I also authorise the use of the aforementioned recordings for live streams (transmission via the internet at the time of recording – at the same time worldwide and time-delayed accessible to anyone), as video-on-demand on an internet platform (always worldwide and time-delayed accessible to anyone) or for storage and publication on the university's media portal (password required – accessible at all times by a limited user group). If required, my authorisation also applies to the forwarding of the recording to public and private broadcasting companies as well as television and other production companies.

This consent for the Hochschule für Musik Dresden is voluntary and may be revoked at any time for future effect. The refusal to provide consent or the revocation of this will not result in any disadvantages.

All withdrawals must be made in writing to: pressestelle@hfmdd.de.

The withdrawal will not affect the legitimacy of any data processing conducted previously. Consent does not automatically end with my departure from the Hochschule für Musik Dresden.

## Declaration of consent – notes

With this declaration of consent I grant my permission for the processing and publication of designated image, sound and (live) streaming recordings. Any processing or publication going beyond this requires a separate agreement.

In the case of withdrawal, the published image, sound and streaming recordings will be removed from the respective platform. If the recordings are available in the internet they will be removed in so far as the Hochschule für Musik Dresden is able to do so. If those affected cannot be identified in image and sound recordings or streaming content with person groups e.g., through name or function-related naming but are only symbolically representing the Hochschule für Musik Dresden, a withdrawal of consent for use is not possible unless the interests of the affected persons outweigh this in individual cases. With planned live streaming (transmission via the internet at the time of recording), in particular, a withdrawal with effect for the future must be made before the transmission.

Via a search machine's archive function, it may still be possible to view data despite the details having already been removed or amended from the Hochschule für Musik Dresden websites.

The publication of content in the internet allows anyone worldwide to access the recordings. It is possible for third parties to download and store recordings and use these for unknown purposes, possibly also in association with other available information – even after withdrawal of consent.

In the case of data protection-related questions or if you would like to exercise your rights (information, withdrawal or correction and restriction of processing / deletion), please contact the HfM Dresden data representative: datenschutz@hfmdd.de. You are also entitled to lodge a complaint with the supervisory authority.

The granting of rights to publication of images occurs without payment and incorporates processing rights as long as any image changes do not result in a distortion of the image.
